- **General**

1. Aftercare provides a light lunch and a snack.
2. The aftercare **closes strictly at 17:15** – please don't enrol your child if you will not be able to collect them at the appropriate time.
3. Please mark all belongings clearly.
4. We follow the same calendar as the school and will thus not be open during public holidays or school holidays. Furthermore, if the school is not open for any other reason the aftercare will also be closed.
5. Staff will not be able to help children in need of extra remedial attention. No staff members are permitted to give extra attention to learners with learning problems.
6. Learners are not allowed to wait at the gate for parents. Please come and sign out your child at the class.
7. Learners must abide by the rules of the aftercare and will not be allowed to undermine the authority of the aftercare staff.

- **Payment**

1. Fees for 2022 will be R650 per month.
2. Fees are strictly payable in advance.
3. No more cash payments will be accepted.
4. All payments have to be made electronically into the following account:

5. All payments have to be made on or before the 3<sup>rd</sup> of each month.
6. The aftercare will run on a month to month basis. If payment reflects in the account on or before the 3<sup>rd</sup> of the month, I take it as confirmation that your child will be attending that month.
7. If no payment is received, you will receive a confirmation message that the aftercare will no longer make provision for your child.
8. 10% handling fee will be effective if we need to refund you for any reason.

- **Rules**

1. All learners must report to the aftercare after school.
2. All learners must have their diaries signed every day.
3. No learner is allowed to play outside if homework is not finished.
4. No learner will be allowed to use the gym.
5. No swearing/hitting/bullying.
6. No playing between classes while the older children are still busy with classes.
7. No learner is permitted to play with non-aftercare children after school hours.
8. No learner allowed to leave school grounds.

- **Homework**

1. All learners are required to do homework before they go outside and play.
2. Diaries have to be signed daily.
3. We do not have the facilities available for practical tasks and speeches. This will be the only homework allowed to be done at home. We require written consent from parents if learner is allowed to do other homework at home.
4. ***It is still the sole responsibility of parents to ensure that all homework is done and up to date.***
